TAX TIME

2025 Tax Information

You will find the interest you earned on your deposit accounts, including IRAs and interest paid on your loans in 2025, disclosed on the last page of your December 2025 statement.

IRS documents such as 1099's or 1098's will be mailed out by January 31, 2026.

If you earned LESS than \$10 in dividends on your share accounts you will not receive a 1099 from the Credit Union as it is not required by the IRS.

If you paid LESS than \$600 in interest for a real estate loan you will not receive a 1098.

2025 IRA Tax Information

The IRS allows members to make 2025 IRA contributions up to the tax filing deadline of April 15th, 2026.

The December 31st, 2025 statement balance is your year-end "FAIR MARKET VALUE".
