Railway Credit Union places holds on deposited checks to protect **YOU** and the credit union. The key factors for check holds are: **Preventing Losses from Returned Checks, Fraud Prevention and Compliance with Regulation CC.**

If a check is fraudulent, altered, or bounced (due to insufficient funds), and the funds were already made available, the **member would be liable for the amount**. If there are not matching fund, a hold gives the credit union time to verify and clear the check through the issuing bank, detect suspicious or unusual transactions - especially large, out-of-pattern deposits. Additionally, with the increased amount of fraud happening within all financial sectors applying a hold on the funds protects members from unknowingly being a victim of scams such as "deposit this check and send money back".

As always contact RCU if you have any questions regarding check holds or refer to your account agreement.
